

RTA Building & Construction Limited Motor home Hire Agreement

PLEASE NOTE: One copy of this agreement to be signed per driver of the hired vehicle and returned to RTA with your deposit.

These terms and conditions apply to all hires of RTA Building & Construction limited Motor homes and as such must be signed prior to hire.

1. Safe and Legal use

The hirer and all additional drivers are responsible for the safe and legal use of the vehicle on hire. This includes but is not exclusive to ensuring the relevant seat belt laws are adhered to, keeping within the speed limits and taking care to ensure responsible driving and parking. Children under the age of 12 should be in a child seat, the supply of the child seat is the responsibility of the hirer.

2. Conditions

The Vehicle can not be driven by:

- A) Hirers under 25 or over 70 years of age
- B) Hirers aged 25 years or over unless a full driving licence, valid in the United Kingdom, has been held for more than 24 months.
- C) Persons who have been convicted of an offence in connection with the driving of a motor vehicle or motorcycle and / or have had their driving licence endorsed or suspended or penalty points imposed. Parking and not more than 2 speeding offences can be ignored. "Spent" convictions, covered by the rehabilitation of offenders act 1974 may be disregarded.
- D) Persons who have any mental or physical defect or infirmity or suffers from fits, diabetes or any heart complaint.
- E) Persons who have had their insurance declined and / or renewal refused and / or special insurance terms imposed as a result of claims experience and / or have their insurance or cover cancelled by any motor insurer.
- F) Persons engaged wholly or partly in professional entertainment or professional sports persons.
- G) Jockeys and persons connected with racing of any sort
- H) Persons who (whilst driving) have been involved in more than one accident during the past 3 years.
- I) Foreign Service personnel other than persons born in the United Kingdom.

3. Required Prior to Hire

A £200 booking deposit will be taken to secure the booking dates. Please make your deposit cheque payable to "**RTA Building & Construction Ltd**" and post it with this agreement to:

This is considered to be part of the hire value and is non-refundable in the event of a cancellation. This payment is considered acceptance of these conditions (as stated on the deposit invoice).

For travel outside of the UK it is advised that the hirer carry a VE103 form. Though it is the hirer who must apply for this RTA Building & Construction will assist in the compilation of the application.

Before collection / delivery of the hired vehicle can take place the hirer(s) must have supplied the following to RTA Building & Construction limited **at least 2 weeks prior to the hire:**

1. Full payment of hire fee (if a deposit has been paid this will be balance of the hire).
2. £300 security deposit (to be returned upon safe return of the vehicle).
3. Proof of Address for each driver (e.g. household bill) other than Driving licence.
4. A signed copy of the hire agreement for every driver.
5. Copy of Driving Licence for each driver.
6. Payment for travel outside of UK mainland (incurs an additional insurance charge of up to £120 per Hire).

RTA Building & Construction limited reserve the right to cancel any booking for which the above conditions have not been satisfied.

The security deposit will be refunded upon safe return of the vehicle less any:

- Fuel Charges
- Cleaning charges
- Repairs
- Waste tank emptying charges

4. Condition and contents of the vehicle

The vehicle will be hired out with the following additional equipment as standard. These items must be returned with the vehicle in the same condition as at the start of the hire:

- Satellite Navigation system
- Bike rack (5 Berth Motor home only)
- A range of Cd's
- Instruction Manual
- Cutlery , Crockery and cooking utensils
- Portable DVD Player
- A range of DVD's
- Towels

Consumables such as tea, coffee, condiments and toilet roll supplied with the vehicle do not need to be replaced.

The vehicle will be clean upon delivery (any defects will be noted on the pre-hire paperwork) and we expect it to be returned with the interior in a clean condition. Any marks or stains that require industrial cleaning will be charged to the hirer. The hirer accepts that RTA Building & Construction's decision on this issue is final.

Please note that there is no smoking allowed in the vehicle. Any hirer that smokes in the vehicle will be charged additional cleaning charges.

5. Breakdown and Repairs

The hirer is accountable for the responsible use of the vehicle during the hire. In the event of a minor expense being incurred (e.g. puncture repair, gas bottle replacement) these costs will be refunded as long as it is clear that the hirer has used the vehicle caringly and responsibly.

6. Fuel and Tanks

The vehicle will be full of fuel at the start of hire and may be returned with any amount of fuel remaining. If the tank is not returned full, RTA Building & Construction will fill the vehicle with fuel and deduct the cost of the fuel from the deposit to be returned. There will be no additional charge or special fuel rate, simply the local garage rate per litre will be deducted.

The vehicle will be supplied with a full water tank and empty waste tanks. Failure to return the vehicle with these waste tanks empty will incur a £50 charge.

7. Insurance

The insurance policy on the vehicle is fully comprehensive and has an excess of £500. The full insurance policy documents are available on request. In the event of an accident the hirer is liable for this excess. The insurance details will be in the instruction pack provided with the vehicle.

8. Delivery and Collection

Delivery and collection of the vehicle should be requested by the hirer upon booking. In case of emergency the hirer should leave a contact telephone number at the point of booking.

10. Declaration

I the undersigned agree to the above terms and conditions of hire and I further agree to be bound by the terms and conditions of the insurance which I have seen and read or have had the opportunity to see and read.
